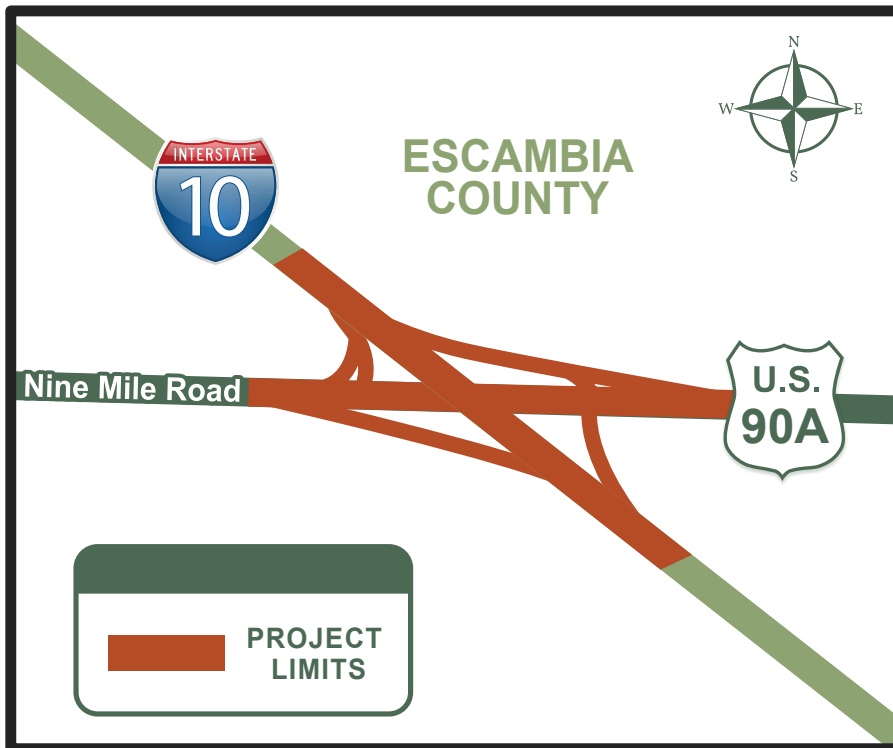




Over Nine Mile Road Bridge Replacement

Escambia County



Project Information

The intent of this project is to replace both existing I-10 bridges over Nine Mile Road to increase vertical clearance and to accommodate future widening of I-10. No additional right-of-way is required.

Bids for construction are scheduled to occur fall 2023.

Anticipated Start Date: Fall 2023
Length: 0.9 miles

Improvements Include

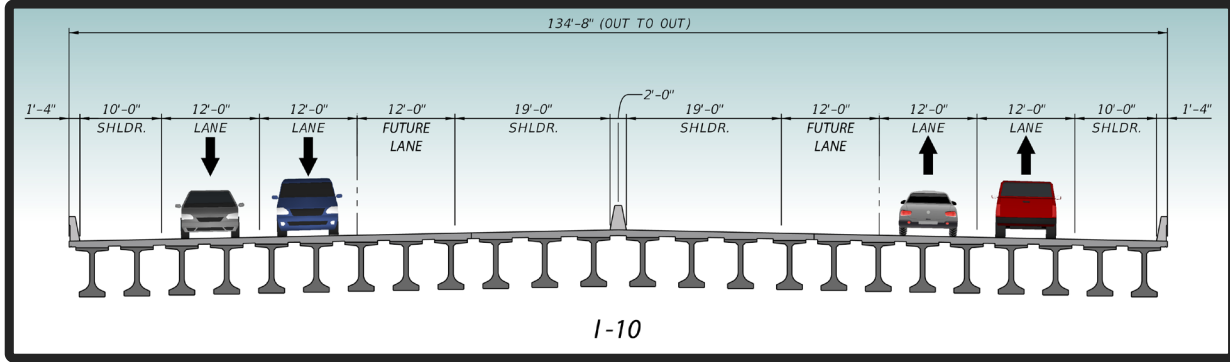
- New bridge will increase vertical clearance from 14-foot 4-inches to 18-foot 3-inches.
- Widening bridge to accommodate for future I-10 and Nine Mile Road (U.S. 90A) improvements.

Traffic Impacts

- Existing lanes will be maintained throughout the project.
- Speed limit on I-10 will be temporarily reduced during construction from 70 to 60 mph.
- Speed limit on Nine Mile Road will be temporarily reduced during construction from 45 to 35 mph.
- Two-lane operation on Nine Mile Road will be implemented during beam setting only.
- Lane closures will only be allowed
 - I-10: 8 p.m. to 6 a.m.
 - Nine Mile Road: 7 p.m. to 5:30 a.m.

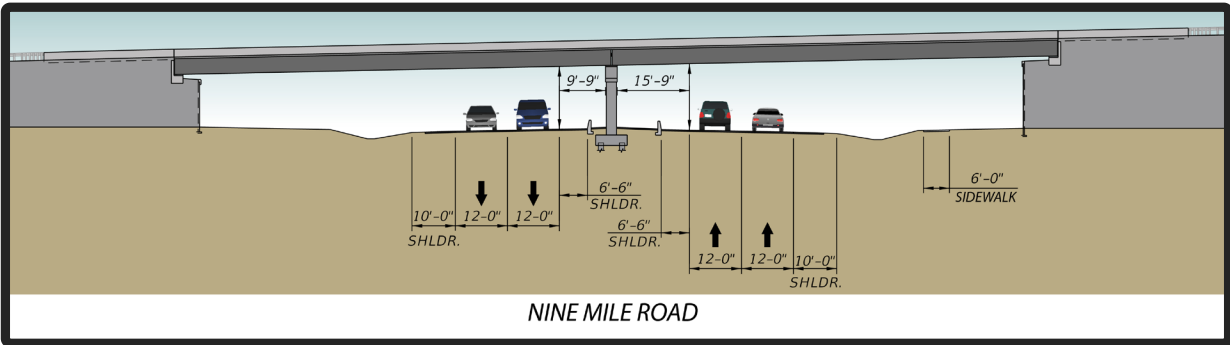
Typical Section

Proposed I-10 Bridge over Nine Mile Road



- Two 12-foot travel lanes in each direction.
- Two 10-foot outside shoulders in each direction.
- Inside shoulders allow for future additional 12-foot travel lanes.

Proposed Nine Mile Road



- Two 12-foot travel lanes in each direction.
- Two 10-foot shoulders in each direction.
- Six-foot sidewalk southside of Nine Mile Road.
