

PROJECT INFORMATION

The intent of this project is to widen approximately 8.5 miles of U.S. 98 (Panama City Beach Parkway) from Mandy Lane to the Hathaway Bridge from 4 to 6 lanes with bike lanes and sidewalks on both sides of the roadway.

Additional improvements include


- Adding traffic signals at Mandy Lane, Gulf Boulevard, and North Glades Trail
- Adding an eastbound left-turn lane into Pier Park
- Adding additional southbound left-turn lane on Alf Coleman Road
- Adding eastbound lane to the flyover toward the Hathaway Bridge
- Reevaluating previously identified noise wall locations for feasibility

Right-of-way acquisition is funded; however, construction is not funded in the FDOT Five-Year Work Program.











To comply with recent travel and public meeting restrictions, the Florida Department of Transportation (FDOT) has updated information to share with you concerning the widening of U.S. 98 from County Road (C.R.) 457 (Mack Bayou Road) to C.R. 30A.

This update is available so interested persons can provide input and/or ask questions. Information regarding this project can also be found online @ nwflroads.com/projects/414132-6.

The intent of this project is to widen a two mile section of U.S. 98 from Mack Bayou Road to C.R. 30A West from four to six-lanes with five or six-foot sidewalks and a ten-foot shared-use path. Pedestrian features at the three existing traffic signals will be upgraded to meet current Americans with Disabilities Act standards. Bids for construction will be accepted in early 2021 with construction activities scheduled to begin spring 2021.







This hearing is being held to provide interested persons an opportunity to express their views concerning the proposed improvements. The intent of the project is to resurface 6.9 miles of U.S. 98 (Panama City Beach Parkway) from the Walton County line to Heather Drive. Design improvements include:

- Constructing a 10-foot multi-use path on the south side and a six-foot sidewalk on the north side, both with lighting
- Adding a concrete barrier wall to continue the sidewalk across the eastbound bridge over Lake Powell
- Constructing left turn lanes in both directions at Palm Beach Drive, Dolphin Drive, and Gulf View Drive
- Constructing eastbound left turn lanes at Gainous Road
- Constructing westbound left turn lanes at Marlin Avenue
- Constructing eastbound right turn lanes at Camp Helen State Park, Le Grand Drive, Twin Lakes Drive, Christmas Tree Lane, and the Front Beach Road signalized intersection
- Upgrading pedestrian features at the Front Beach Road signalized intersection to meet current Americans with Disabilities Act standards.

No additional right-of-way is needed. Bids for construction will be received fall 2020.





PROJECT INFORMATION

As part of the FDOT's continued efforts to increase safety on state roadways, a lighted pedestrian underpass is proposed to be constructed just east of the U.S. 98 and C.R. 30A intersection. The underpass will be approximately eight feet high, twelve feet wide, and 136 feet in length. Traffic shifts will be utilized to maintain the same number of lanes on U.S. 98 and C.R. 30A during construction. This project will also add an U.S. 98 eastbound right turn lane to C.R. 30A. Right-of-way acquisition is funded this fiscal year. However, construction is not funded in the current FDOT Five-Year Work Program




