





ALTERNATIVES

No Build Alternative: Consists of leaving the Westbound Old Trammel Bridge in place, continuing the current roadway configuration, and conducting routine inspections until the bridge is phased out at the end of its serviceable life.

Build Alternative 1: Consists of leaving the Westbound Old Trammell Bridge in place but taking the bridge out of service. The existing eastbound bridge will be converted into one travel lane in each direction, the roadway and existing stormwater drainage systems will be modified, and a sidewalk will be constructed within the southern right-of-way (ROW) from the existing eastbound bridge to Bristol.

Build Alternative 2: Consists of removing the Westbound Old Trammell Bridge and converting the existing eastbound bridge into one travel lane in each direction. The bridge approaches for Westbound Old Trammell Bridge will be removed, stormwater drainage systems will be improved, and a sidewalk will be constructed within the southern ROW from the existing eastbound bridge to Bristol.
